## **ABOUT THE GUIDE**

TBR is committed to creating and assisting with education and workforce development solutions for all Tennesseans, including those who may be justice-involved. Because individuals with prior convictions or criminal history often face discrimination with regards to occupational licensure, this guide seeks to offer guidance and dispel myths regarding occupational licensure both for prior justice-involved students as well as stakeholders such as advisors, college personnel, and others who may act as gatekeepers to these various occupations.

While this guide is not comprehensive, it does present licensure pathways and information for 12 in-demand occupations requiring licensure in Tennessee.

In order to gain employment in some fields, an individual will be required to obtain occupational or professional licensure by a state agency. The licensing agency and their procedures are explained in this guide along with any applicable barriers for prior justice-involved individuals.

Obtaining licensure does not guarantee an individual a job in a field, but it may be required in order to work in that field.



## ABOUT TBR: THE COLLEGE SYSTEM OF TENNESSEE

TBR - The College System of Tennessee is the largest system of higher education in Tennessee, with 13 community colleges and 26 technical colleges across the state offering more than 400 programs of study. It is governed by the Tennessee Board of Regents. The board meets four times a year at regularly scheduled meetings, and the chairman may call additional meetings during the year as needed. The board sets policies and guidelines that govern all TBR institutions. All board meetings are open to the public and the press as observers under Tennessee law.

## **KNOW YOUR RIGHTS**

The state of Tennessee is committed to assisting all Tennesseans to find gainful employment and contribute to the overall workforce development. As such, several applicable laws have been passed in recent years specifically designed to help prior justice-involved individuals move past their prior mistakes to build a future that involves a good job. While a job or licensure is not guaranteed, learning about these laws can help you gain employment. The information provided below is provided for informational purposes only and does not represent legal advice by TBR.

#### **FAIR CHANCE ACT (2016)**

T. C. A. § 8-50-112, colloquially known as "ban the box," prevents certain **state agencies or entities** from initially asking about prior criminal background in a job application unless the job requires a background check under federal law or is a job in education.

#### TN FRESH START ACT (2018) Public Chapter 793

Generally, provides that denial of occupational licensure for a prior conviction can only be done if the crime directly relates to the field of license.

#### **MORAL TURPITUDE**

Many health occupations will include a moral turpitude clause that can become problematic for prior justice-involved individuals. Offenses of moral turpitude include <u>bribery, fraud, drug charges, and prostitution</u>.

#### **FEDERAL BONDING PROGRAM**

The federal bonding program is available to employers as a sort of insurance program to incentivize the hiring of prior felons upon re-entry. You might consider mentioning this program to a potential employer as an incentive at hiring, as this program will pay a portion of the salary for a prior felon that is hired and successfully maintains employment.

An individual interested in pursuing any of the programs outlined below is responsible for independently verifying the requirements and procedures necessary to obtain a license as well as determining whether any prior arrest or conviction will prohibit the individual from being able to obtain the license. In the event there is any question about an individual's ability to obtain a license, TBR encourages individuals to contact the appropriate board prior to beginning training or a course of study.



## **BUILDING INSPECTOR**

#### **Licensing Requirements**

- Submit completed <u>application</u> and eligibility verification <u>form</u> (\$45 fee).
- Successful completion of a recognized and accepted <u>training course</u> provided by an identified professional building codes organization.
- Successful completion of an affiliate examination.
- Pay \$254 initial license fee.
- Must be certified by the International Code Council or the National Fire Protection Agency.

#### **Renewal Requirements**

- Renewal required every three years.
- Submit a completed renewal application along with a \$35 fee to State Fire Marshal's Office.
- 36 hours of continuing education during three-year period.
- Pay \$315 renewal fee.

#### How will having a criminal record affect getting a license?

(c): An individual, applicant, licensee, certificate holder, or registrant who receives written notice pursuant to subdivision (b)(2) or (b)(3) may file a petition within thirty (30) business days of the receipt of the notice in Davidson County chancery court. The licensing authority must demonstrate by a preponderance of the evidence that the individual, applicant, licensee, certificate holder, or registrant's conviction is related to the applicable occupation, profession, business, or trade.



## CHILDCARE/ DAYCARE EMPLOYEE -

#### **Licensing Requirements**

All individuals working in licensed child care in Tennessee must submit to a criminal history background check through the Tennessee Bureau of Investigation (TBI).

- Each applicant must complete a Disclosure Form which is retained by the child care
  agency. Applicants who have lived out-of-state in the last five years no longer need to complete
  a separate Supplemental Disclosure Form because all the elements from that form have been
  included in the revised form: Child Care Criminal/Juvenile History & State Registry Review Disclosure
  Form.
- Each applicant must be fingerprinted: Instructions for Fingerprinting.
- Each applicant must retain proof of being fingerprinted by returning the signed receipt to the child care agency to be attached to the Disclosure Form.
- The agency must enter the TCN number on the Disclosure Form. This number is located on the fingerprinting receipt.

Information about obtaining the Originating Agency Identifier (needed to register to be printed) can be found at: Background Check Terms & Procedures.

Find a live-scan fingerprinting location and schedule an appointment to be printed at Fingerprinting Enrollment Screen.

The overall background check process includes a check of any applicable out of state registries if the applicant has lived in another state during the last (5) years. Please see the instructions for completing the out of state registry check portion of the background check process at Out of State Registry Check.

## How will having a criminal record affect getting a license?

Criminal offenses for which a person must be excluded from a child care agency include physical, sexual or emotional abuse or neglect of a child, crimes of violence, any offences that present a threat to the health, safety or welfare of children, and drug related offenses. Specific examples of excludable criminal offenses include aggravated assault, arson, child abuse, cruelty to animals, domestic assault, indecent exposure, reckless endangerment, robbery, stalking, vehicular assault, voluntary manslaughter, and weapons offenses. ## **COMMERCIAL DRIVER'S LICENSE (CDL) -**

#### **Licensing Requirements**

- Must be at least 21 years of age.
  - > EXCEPTIONS: if you operate a vehicle solely intrastate and within 100 miles of job, and your vehicle requires no special endorsements, you may obtain a B license at age 18. At age 19 you can obtain a Class A or Class B license without endorsement.
- Must not currently be under a driver license suspension, cancellation or revocation.
- Pass Knowledge Test (more tests depending on the type of freight you carry).
- Pass Commercial Skills Road Test (<u>Scheduling Information</u>).
- Submit a Medical Certificate via a certified doctor (most doctors qualify).
- Include an Affidavit of Self-Certification, and
- Medical Examiner Certification (Form MCSA 5876).
- Provide proof of Social Security Number.
- Proof of United States citizenship (example: valid passport, birth certificate).
- Provide Tennessee driver's license or ID, or a valid driver's license or Commercial Driver's License (CDL) from another state.
- Two documents of proof of domicile in Tennessee (example: current utility bill and mortgage papers).
- Pay \$46 for a Class A license (\$6 non-refundable application fee + \$40 license fee).

#### **Renewal Requirements**

- Required every two years.
- Submit updated Medical Certificate (make sure your certificate has a two-year expiration, otherwise must renew sooner).
- Renewal Information.

- Fingerprint-Based Background Check if Applying for Hazardous Materials Endorsement (HME).
  - > TSA must determine (within 90 days prior to the application) that the applicant does not pose a security threat before HME may be issued.
- Traffic, alcohol, felony violations relevant to maintaining license.
  - > Ex: Lose license for life if you use a CMV to commit a felony involving controlled substances.

## How will having a criminal record affect getting a license?

Having a felony does not mean someone cannot get a license, it just requires a couple extra steps in the licensing process.

If there is an applicant that was convicted of a felony within the last three years, the documents that must be submitted to the board along with the "Application to Test" are as follows:

- Letter of Recommendation from the applicant's instructor or school administrator. This usually has a request for the board to grant the applicant a license.
- Written statement of charges (can be a rap sheet) that includes circumstances of charge and disposition.

Note that if no felony occurred within the past three years, this process is not required.

#### **Licensing Requirements:**

Electrical work is licensed at various levels in Tennessee (State and Local). The need for a state LLE license is based upon the following:

The total cost is less than \$25,000; (amount includes materials and labor, unless supplied by the owner (cannot be supplied by the prime/general contractor). [See Rule 0680-1-.13]

Location of the project; check with the local government in the city and county's <u>Local Codes</u> <u>Enforcement</u> office to see if the LLE is accepted for permits and inspections, or if a local electrical journeyman/master license is required. <u>This information has been compiled here</u>.

A "Business" tax license may also be required by local government.

A state <u>Contractor</u>'s with an electrical (CE) classification (comparable to a "Master Electrician") is required to perform projects \$25,000 or more. The LLE exam is not reciprocal with other states electrical license exam. The <u>Division of Fire Prevention</u> adopts codes and their law covers electrical installations and inspections for LLE's in some local governments. The electrical law may be reviewed at T.C.A. 68-102-150 at: <u>LexisLaw Publications</u> (see Tennessee section).

- Complete licensing application.
  - > Complete citizenship status form (page 5 of application).
- Satisfactory completion (72.5 percent correct) of examination.
  - > Costs \$53
- Pay \$50 initial licensing fee.

## **Renewal Requirements**

- Renewal required every two years.
- Pay \$50 renewal fee (additional \$10 for every month renewal is late, up to \$80).
- No continuing education requirements.

#### How will having a criminal record affect getting a license?

- Criminal background check required.
- If you have been convicted of a felony in any jurisdiction, you must attach a statement explaining the details of the conviction, supply a copy of the charging document, the disposition and proof of any sentence or court order, and release of probation.
  - > Before a license is granted to anyone with a conviction, the Board requires review of the criminal background documents for the complete criminal history and timeline.
  - > In addition, if you have had disciplinary action against another professional license or a complaint history you may be required to appear before the Board which meets at least six times annually.

A felony conviction does not automatically preclude someone from licensing, however, it does require the Board's approval. If you have been convicted of a felony in any jurisdiction (Tennessee or any state), you must attach a statement explaining the details of the conviction, supply a copy of the charging document, the disposition and proof of any sentence or court order, and release of probation. Before a license is granted to anyone with a conviction, the Board requires review of the criminal background documents for the complete criminal history and timeline. In addition, if you have had disciplinary action against another professional license or a complaint history you may be required to appear before the Board which meets at least six (6) times annually.

The Board is charged with protecting the safety and welfare of the public and they will judge each individual case on it's own merit. The law requires disclosure of felonies, as well as any court litigation and judgments. A license is not automatically denied due to judgments and convictions, however, failure to disclose is a violation of law and a civil penalty may be assessed for not providing true and correct information, such as the license also being denied or revoked. Consumers or licensees may report known violations to the Board anonymously.

#### Review the LLE License Law, Rules and Regulation

It is very important to ensure you are knowledgeable with the license laws, rules and regulations. These laws are covered in both the Contractor's law and the Division of Fire Prevention's law. These may be reviewed from our website at the "Laws, Rules and Regulations". Failing to be familiar with the law could cause violations affecting your license. For example, Limited Licensed Electricians (LLE) licensees cannot use the term or advertise as a "Contractor". Never allow another individual to use your license (considered aiding in unlicensed activity). If you perform work in an area regulated by another state agency (such as the Alarm Systems Board), be sure to obtain their required licenses. In addition, a LLE licensee cannot perform work where the total electrical on a project or contract is \$25,000 or more; contracts cannot be split into phases to circumvent the contractor licensing law. If you want to be licensed to perform projects \$25,000 or more, you'll need to obtain a "Contractor's" license with a CE (electrical) classification. Also, be sure to notify the Board's office of any change in mailing address. When using a P.O. Box for mail, you must also supply a physical address.

Always check with the local municipality for permits and inspections, as well as, for their own electrical license requirements. In areas where there is not a codes office, the state's Fire Marshal performs inspections.

#### **Licensing Requirements:**

- Must be at least 17 years of age.
- Must be able to read, write, and speak the English language.
- Must not have any history within past three years of habitual intoxication or personal misuse of any drugs or intoxicating liquors in such a manner as to adversely affect the ability to practice as an EMR.
- Must have successfully completed a board approved Emergency Medical Responder training program.
- Must obtain a passing score on a board approved written examination.
- Must submit an application and required certification fees.
- Must complete are requirements for certification within two years of course completion date.
- Must complete all certification requirements within two years of course completion date; if not, the application will be considered abandoned and will be destroyed.

#### How will having a criminal record affect getting a license?

Tennessee EMS Rules and Regulations require a criminal background check for any person seeking a license with the Office of EMS. A misdemeanor will usually not preclude a person from being licensed. Exceptions would be a habitual offender or someone with a known drug or alcohol addiction. As a matter of policy, licensure applications are denied to anyone with a felony conviction or who has served a sentence greater than 11 months and 29 days. However, an applicant who has been denied may appeal to our EMS Board for licensure. While it is rare for the EMS Board to grant an appeal, they do occur in some cases.

#### **Licensing Requirements** (TCA 62-6-103):

- Complete online contractor licensing application.
  - > Exams Licenses are issued with a Classification based on passing "Business and Law" and applicable "Trade" Examination); Exam cost is \$53 for each exam with PSI.

Classifications include: Building (Residential/ Commercial); Electrical; Mechanical; HVAC; Plumbing; Landscaping; Roofing, Excavation; Municipal Utility (Waterlines); Heavy Construction (Welding/Storm Damage Cleanup/Demolition); etc.

> Financial Statement - Prepared by a licensed Certified Public Accountant (CPA).

License is issued in the name listed on the financial statement; Monetary limit is based upon 10% of Working Capital and Net Worth.

- > Insurance for General Liability, and Workers' Compensation or WC Exemption Registration as Construction Services Provider; Experience and Reference from past Client, Employer or Codes I.
- Fee: \$250 initial licensing fee (may qualify for low-income waiver).

## **Renewal Requirements**

- Renewal required every two years.
- Pay \$200 renewal fee.
- Insurance for GL and WC or Exemption; Financial statement (may be self-prepared) .
- Beginning January 2022, residential licensed contractors are required to obtain eight hours of continuing education.

#### How will having a criminal record affect getting a license?

Applicants are required to disclose felony convictions with written statement explaining conviction: age at time of conviction; description of crime; activities that lead to conviction; improvements and changes or clean criminal history since conviction; copy of the official charging document (court order); probation or parole status; character reference; and Background Report of Tennessee Criminal History from Tennessee Bureau of Investigation (TBI).

License denial due to felony convictions would require the licensing authority to demonstrate conviction is related to the applicable occupation, profession, business, or trade.

License Approval - It takes approximately four to six weeks to be granted a license (do NOT contract, bid or offer prior to obtaining a license). Board review and approval is required and this is at their regularly scheduled meetings (see Public Meeting Information for dates). An appearance or interview with the Board may be waived as long as there is not a complaint history, conviction, or judgment by any of the individuals or qualifying agents applying for a license; or for ones who did not take the exams, such as the BC-A/r (restricted limited residential license); and if there is not any experience provided. If an interview is required, the qualifying agent and the owner (if different) must both appear.

Interview Not Waived - You will be notified in writing of date, time and location to appear. These meetings are held held in January, March, May, July, September and in November.



## **HEATING, VENTILATION AND AIR CONDITIONING (HVAC)**

- Must successfully pass LLE licensure examination.
  - > Examination information
  - > \$53 examination fee.

#### Rights & Appeals - Fresh Start Act 62-76-104

License denial due to felony convictions would require the licensing authority to demonstrate conviction is related to the applicable occupation, profession, business or trade.

Entry level positions for this position may not require more than a high school diploma. Improve your odds at finding a job with the following programs. Training available at the following institutions:

## How will having a criminal record affect getting a license?

The mission of the board of nursing is public protection. Each situation is reviewed individually; the outcome depends on the circumstances and the composition and position of the board at the time of application. An applicant with a felony conviction may be issued a single state license; the board may deny licensure if there is a danger to the public.

CNA requires certification rather than licensure. The Nurse Aide Registry is housed administratively under Health Care Facilities as all of the laws and regulations that govern the registry fall under Nursing Home care.

The TN law related to background checks is located at TCAA 68-11-256 titled "Criminal background checks on direct care employees of nursing homes". There is no restriction on actual certification as a nurse aide except placement on the Registry of Persons Who Have Abused, Neglect or Misappropriated the Personal Property of a Vulnerable Individual (TCA 68-11-1001, et seq). The final decision rests with the employer; the employer is held harmless if they refuse to hire an individual with a prior conviction.

Because nursing is an incredibly in-demand occupation, admission to education has become competitive. It is recommended that any prior convictions are expunged prior to application to any nursing training program.

- Tennessee driver's license, or a valid driver's license or CDL from another state.
- Proof of residency in Tennessee (through documentation or immediate relatives).
- Pass CDL general knowledge test to earn learner's permit.
- Retain permit for at least 14 days.
- Pass additional endorsement test (c)(2) Passenger knowledge & skills test.
- Schedule and pass the CDL skills test by calling (615) 502-4179.

- Subject to <u>TSA Background Check</u>: Conviction for one of the following felonies is disqualifying if the applicant was released from incarceration after conviction within five years of the date of the application:
  - > Unlawful possession, use, sale, manufacture, purchase, distribution, receipt, transfer, shipping, transporting, delivery, import, export of, or dealing in a firearm or other weapon. A firearm or other weapon includes, but is not limited to, firearms as defined in 18 U.S.C. 921(a)(3) or 26 U.S.C. 5 845(a), or items contained on the U.S. Munitions Import List at 27 CFR 447.21.
  - > Extortion.
  - > Dishonesty, fraud, or misrepresentation, including identity fraud and money laundering, where the money laundering is related to a crime listed in Parts A or B (except welfare fraud and passing bad checks).
  - > Bribery.
  - > Smuggling.
  - > Immigration violations.
  - > Distribution, possession w/ intent to distribute, or importation of a controlled substance.

- > Arson.
- > Kidnapping or hostage taking.
- > Rape or aggravated sexual abuse.
- > Assault with intent to kill.
- > Robbery.
- > Fraudulent entry into a seaport as described in 18 U.S.C. 1036, or a comparable State law.
- > Violations of the Racketeer Influenced and Corrupt Organizations (RICO) Act under 18 U.S.C. 1961, et seq., or a comparable state law, other than any permanently disqualifying offenses.
- > Voluntary manslaughter.
- > Conspiracy or attempt to commit crimes in this section.

## Rights and Appeals - Fresh Start Act 62-76-104

An individual, applicant, licensee, certificate holder, or registrant who receives written notice pursuant to subdivision (b)(2) or (b)(3) may file a petition within 30 business days of the receipt of the notice in Davidson County chancery court. The licensing authority must demonstrate by a preponderance of the evidence that the individual, applicant, licensee, certificate holder, or registrant's conviction is related to the applicable occupation, profession, business, or trade.
